

It is of paramount importance that we protect communities from this deplorable drug.

According to reports, even though Flakka is illegal, foreign companies still sell the substance online. Unfortunately, their laboratories have become a source for drug cartels in North and Central America. It is my hope that you will do all that is in your power to prevent this drug from spreading any further than it already has. To that point, I am urging the DEA to take the necessary steps to prevent Flakka from being sold by internet distributors to persons in the United States. It is imperative that the DEA continue working diligently -- and if needed work with other federal agencies, credit card companies, and online retailers -- to halt all online transactions.
