Dear Secretary Buttigieg and Administrator Whitaker,

We write to you regarding Section 1102 of H.R. 3935, the FAA Reauthorization Act of 2024, which was signed into law by President Biden on May 16, 2024. The bill requires the Department of Transportation, in coordination with the Federal Aviation Administration, to convene a working group within 90 days to develop best practices and identify hindrances for transporting donated organs in the cabin of commercial aircrafts.

The working group will support the modernization of federal protocols that reduce the risk of damaging or delaying donor organs traveling through the nation's commercial air system. These modernizations are critical to ensuring the gifts of life entrusted to us by organ donors and their families reach their intended recipients safely and efficiently.

We urge the Department to begin forming the working group as soon as possible in accordance with the provisions outlined in H.R. 3935. Additionally, we encourage transparency and open communication throughout the process to ensure the working group's efforts are in line with the provision's intent.

Thank you for your attention to this important issue. We look forward to witnessing the positive impact this working group will have on organ donors, transplant recipients, and their families.
