## **A BILL**

To amend the Public Health Service Act to authorize the Secretary of Health and Human Services to carry out a program of research related to cerebral palsy, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Cerebral Palsy Re-
- 5 search Program Authorization Act of 2023".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:

1	(1) Cerebral palsy is the most common motor
2	disability in children, affecting more than 1,000,000
3	Americans, 1 in 345 children, and over 17,000,000
4	people worldwide.
5	(2) In the United States, more than 10,000 ba-
6	bies are diagnosed with cerebral palsy each year.
7	(3) Cerebral palsy is a broad group of disorders
8	disrupting a person's ability to move, sit, stand,
9	walk, talk, and use their hands.
10	(4) In more than 80 percent of cases, the cause
11	of cerebral palsy is unknown.
12	(5) Seventy-five percent of individuals with cer-
13	ebral palsy also have 1 or more additional develop-
14	mental disabilities including epilepsy, intellectual dis-
15	abilities, communication problems, learning and at-
16	tention disorders, chronic pain, autism, hearing dis-
17	orders, and visual impairments or blindness.
18	(6) Children with cerebral palsy are more likely
19	to die from the flu and related viruses, including
20	COVID-19, than children without neurologic dis-
21	orders.
22	(7) There is no consensus of best practices for
23	a person with cerebral palsy at the time of diagnosis
24	or through the lifespan.

1	(8) It is estimated that the lifetime care and
2	medical costs for all people with cerebral palsy who
3	were born in 2000 alone will total more than
4	\$13,500,000,000. The loss of productivity and lost
5	wages of the individual with cerebral palsy and their
6	family members is more than \$35,000,000,000.
7	(9) There is no known cure for cerebral palsy,
8	and in most cases, it is not preventable.

21	"(d) Authorization of Appropriations.—To
22	carry out this section, there is authorized to be appro-
23	priated \$5,000,000 for each of fiscal years 2024 through
24	2029.".
