I am requesting funding for the Kansas City Area Transportation Authority's Public Safety Technology project in fiscal year 2026. The entity to receive funding for this project is the Kansas City Area Transportation Authority, located at 1200 E. 18th St., Kansas City, MO, 64108. The funding would be used to increase public safety by purchasing and implementing various forms of security systems for local law enforcement officials.

The project is an appropriate use of taxpayer funds because the increase in crime among transit corridors is a pattern seen across the nation, and with public safety among the top priorities of the Federal Government, this project directly ties into local priorities.
